Maximum number of student enrolled through a study center shall not exceed 100 in a (ii)

The Principal or a senior member of the institution shall be appointed as the Co-(iii) Oordinator.One faculty member of the institution shall be appointed as the Coordinator. One faculty member of the institution shall be appointed as Assistant Co-ordinator. Supporting staff required for smooth running of the Programme will be provided in the study Center. The remuneration to be paid to the Co-Ordinator/Assistant Co-Ordinator and the supporting staff will be fixed by the University.

9. Academic Input

Self-learning Print courseware designed and developed and developed as per NCTE norms will be made available to the students.

A minimum of 300 contact hours including two compulsory contact (ii) programmes(workshops) each of 2 weeks duration evenly spread throughout the course shall be arranged in the Study Center for each student. The contact programmes will be conducted by teache education from the university/training colleges. The maximum number of students in a contact class be fifty.


